

REPORT FROM THE GOS AAOS BOARD OF COUNCILORS

Since last reporting, the major focus of your AAOS BOC has been **ADVOCACY**. In the past year, the AAOS Office of Government Relations (OGR) has worked to secure \$300 million in COVID-19 relief from the CARES Act, increased payments for telehealth visits, minimized Medicare payment cuts, fought for a physician-friendly compromise in the form of independent dispute resolution (IDR) on the issue of surprise billing, and leveled the playing field between physicians and insurers by advocating for the repeal of the McCarran-Ferguson Act (anti-trust). We truly have seen some incredible wins in the past year, in large part due to the fact that our Orthopaedic PAC gave us a seat at the table to make our voice heard during these legislative showdowns.

We have just completed AAOS Advocacy Week, during which your 3 BOC Representatives wrote many of you encouraging donations to the Orthopaedic PAC. On May 27th we had virtual visits with many of our Representatives and our 2 Senators on Capitol Hill. This project was the brainchild of our AAOS president Dr. Danny Guy from Lagrange who served as GOS president in 2009. We asked them to cosponsor legislation to improve the prior authorization process, the Telehealth Modernization Act which seeks to continue telemedicine funding

after Covid, and to support physician mental health by co-sponsoring The Dr. Lorna Breen Health Care Provider Act. This legislation will help reduce and prevent mental and behavioral health conditions, suicide, and burnout among health care professionals.

Hopefully, we will have in-person meetings on Capitol Hill at the September National Orthopaedic Leadership Conference (NOLC)/ AAOS Fall Meeting. These two meetings will be combined for the first time.

As always, we not only bring news back to you, but we are your conduit back to the AAOS when you have concerns. Please allow us to help you.

GOS LOBBYIST REPORT

2021 Legislative Session



The 2021 Legislative session wrapped up in the early morning hours of April 1st. Overall the Session was a success for physicians. Doctors are making an impact at the General Assembly with our unified voice as well as strong representation in the Legislature. We now have four doctors in the General Assembly – three in the Senate and one in the House. Dr. Ben Watson remains as the Chairman of the Health Committee in the senate and Dr. Dean Burke was very effective in his first year as the Chairman of the Insurance Committee.

Below are some of the highlights for the medical community.

COVID liability protections:

HB 112 – (Representative Trey Kelley) Physicians were protected from COVID liability in the 2020 legislative session. This year we were able to extend these protections for one year until July 14, 2022. This bill has been signed by the Governor.

Insurance Reform:

HB 234 – (Representative Lee Hawkins) In 2020, the legislature passed the Surprise Billing Consumer Protection Act to protect patients from surprise bills and to protect physicians from payment denial. This bill allows self-funded plans to opt into this Act. This bill has been signed by the Governor.

HB 454 – (Representative Mark Newton) This bill deals with the continuity of care issue that has long been an issue with multiple insurance plans. The bill provides that a plan must provide coverage for 180 days if a patient's provider becomes out-of-network during a plan year. This bill has been signed by the Governor.

SB 80 – (Senator Kay Kirkpatrick) This bill deals with the burdensome prior authorization process. The bill does a number of things to assist – (1) Requires insurers and PBMs to be transparent with providers and patients about changes in their prior authorization process. (2) Allows for a physician in the same specialty to negotiate in the process. (3) Requires insurers to respond to requests within 15 calendar days until January 1, 2023; within 7 days after January 1, 2023, and within 72 hours for urgent care. This bill has been signed by the Governor.

Telemedicine services update

SB 307 – (Representative Sharon Cooper) This bill cements into law Governor Kemp's executive order stemming from the COVID-19 pandemic. The bill authorizes healthcare providers to provide telemedicine services from home as well as authorizes patients to receive these services from their home, workplace or

school. The bill allows for audio-only care when under certain circumstances. Additionally, it prohibits insurers from requiring an in-person consultation before receiving telemedicine services. This bill has been signed by the Governor.

Scope of Practice

Often times wins are not found in bills passed but in bills not passed. This is the case with HB 369. The bill would have allowed for APRN and PA prescribing of Schedule II drugs under a protocol agreement or a job description. The bill would also allow APRNs and PAs under a protocol agreement to sign an affidavit for parking permits for people with disabilities. Further the bill removed some of the oversight of the Composite Medical Board when dealing with scope under protocol agreements by physicians. This bill failed to receive a vote in the Senate. We fully expect this bill to return. Representative Burt Reeves and Representative Alan Powell were the main legislators pushing the bill. Representative Reeves will not be returning to his seat in 2022 but we fully expect Representative Powell to push this concept.

Tort reform

After the attempt to pass an omnibus tort reform package in 2020, this year's efforts took a more targeted approach. Two main issues came before legislators – phantom damages and trial bifurcation. Both provisions were attached to bills late in the session. While both bills passed the Senate Health Committee, neither ultimately passed the legislature. Language dealing with phantom damages was removed in the Senate Rules Committee due to the controversial nature and a desire to easily pass the underlying bill. Trial bifurcation failed on the Senate floor. With lots of new faces in the legislature and many others coming, the off-season will be spent educating legislators and building support for this issue.

Other legislation of impact

While we passed key legislation that will enable physicians a better practice environment in Georgia there are other bills unrelated to medicine that made headlines this year.

Election reform was front and center from Day 1. The bill that ultimately passed was SB 202. You have probably heard many different opinions on this bill. For your reference, you can find the bill <https://www.legis.ga.gov/legislation/59827>. This will undoubtedly be a top issue as campaigns continue to heat up.

Governor Kemp signed HB 479 repealing Georgia's antiquated citizen's arrest law, which was authored in 1863. The bill

significantly revises the grounds for arrest and detainment by a private citizen. The bill passed both chambers with bi-partisan support and a nearly unanimous vote. This was one of the Governor's priorities following the civil unrest from the summer of 2020.
